
ABOUT i&i PRAGUE

OUR ROLE




Two major roles of i&i Prague:

- Evaluation and investment: i&i Prague screens the biotech projects and evaluates the most promising ones for investment eligibility. Since Sep 2021 i&i Prague offers investment via i&i Biotech Fund. i&i Prague is responsible for the deep technology, team, market, IP assessment.


