Unipetrol Group at glance

- Leading refining and petrochemical group in the Czech Republic and major player in Central Europe
- Since 2005 part of the largest refining and petrochemical group in Central Europe – Polish PKN Orlen that holds 63% ownership interest of Unipetrol, the company is quoted on the Prague Stock Exchange
- 2 refineries Litvínov and Kralupy
- Petrochemical units fully integrated with Litvínov refinery
 - Steam cracker Heart of petrochemical complex processing feedstock from refineries
 - 3 polymer units
- Retail distribution of fuels with 338 fuel filling stations (Benzina Plus and Benzina)
 - Czech market leader with estimated market share of 15%
- Broad range of transport services (Petrotrans and Unipetrol Doprava)
- Revenues in 2014 CZK amounting 124 billion CZK (ca 4 billion EUR)

- Polymer Institute Brno research in plastics










Unipetrol Group:
